(1) To date the total cumulative amount forgiven for Step 2 is \$26,666,666.64.

(2) Imperial Valley Healthcare District/Pioneers Memorial Hospital (IVHD) withdrew its Loan Modification Application for Step 2 and intends to resubmit following completion of its merger with El Centro Regional Medical Center. IVHD has subsequently made two monthly payments of \$518,518.52, reducing the outstanding balance to \$26,962,962.96.

(3) Ridgecrest Regional Hospital (Ridgecrest) withdrew its Loan Modification Application for Step 2 and intends to resubmit once its financial condition more closely aligns with the loan forgiveness criteria. Ridgecrest has subsequently made one monthly payment of \$101,851.85 reducing the outstanding balance to \$5,398,148.15.

(4) Hazel Hawkins Memorial Hospital has not submitted a Loan Modification Application for Step 1 and has subsequently made monthly payments of \$50,000 reducing the outstanding balance to \$2,450,000.
